






Rabobank 2018 poultry trade map





Production % development 2012-2017





Poultry consumption per capita 2017











EU-28 Imports from selected partners in 2017/18





Animal Welfare



- The health and welfare of animals is one of the cornerstones of AVEC and the European poultry meat sector
- For many years, animal welfare has been a priority for the European Union. We are world leaders in animal health and welfare in terms of standards and legal regulations



Animal welfare – due to legislation!

Issue	EU	USA
General protection of poultry	Legislation on buildings, cleaning, system back-up and staff numbers	Not in legislation, the Animal Welfare Act excludes farm animals
Specific welfare requirements for broilers	Legislation on stocking rates; Litter quality; Lighting (pattern & intensity); Maximums for CO ₂ and NH ₃ in houses, if higher stocking rates are used	No legislation; Guidelines* state maximum stocking density and requirements for light and NH ₃
Maximum journey time during transport	Maximum journey time of 12 hours for poultry to slaughter (excluding loading and unloading)	'28 hour law'; No transport time limits in the NCC animal welfare program
Drivers and staff during transport	Legislative requirements for competence and authorisations for longer journeys	No requirement in legislation and not covered in NCC program



AVEC and the European poultry meat sector are committed to **promoting the responsible use of antibiotics**.




AVEC is dedicated to **minimizing the risk of AMR** by keeping the use of antibiotics as low as possible

AVEC is **banning the prophylactic use** of antibiotics to prevent resistant strains of bacteria developing


AVEC believes in the ‘One Health’ approach:



Salmonella as an example



- EU coordinated control programs for *Salmonella* through the consumption of food have been a major success story in the EU
- While before 2004, more than 200.000 human cases were reported each year in the 15 EU countries, it dropped to less than 95.000 cases in 2016 in 28 EU countries.

Biggest analysis to date reveals huge footprint of livestock - it provides just 18% of calories but takes up 83% of farmland




